**STUDIO POLICIES:** Tuition is due on a monthly basis. Payment is due by the first lesson of each month. If you cannot make it to the studio by the first week of the month, the tuition can be mailed in. There will be a \$10 late charge for any tuition not received by the 10<sup>th</sup> of the month. No post-dated checks or money orders will be accepted for payment. We will also be accepting credit card payments (visa&mastercard&discover only) as well as cash and checks (Checks will not accepted after May 10<sup>th</sup> for any tuition or outstanding fees, cash or credit card only). There are neither refunds nor extensions for missed classes. You must call the studio if you will be absent for more than 2 weeks. There are no skipped months for tuition. If your child is absent for a month or more tuition must still be paid. If tuition is not paid, you will be considered dropped from the class and your tuition is not refundable. You have eight weeks to make up a class and you must call in advance to notify the studio of the class you will be attending. If there are no convenient class for you, the missed classes are still not refundable. N.E.D.A is not responsible for any lost or stolen articles left in the studio. Any class may be cancelled depending upon registration. All students must be in proper attire to participate in class.

The member agrees that the school and its instructors, agents, employees, operators and authorized representatives, shall not be responsible for and are hereby released from any liability, claim, loss, including loss of property, damage, personal injury or expense incurred by a member or anyone claiming through a member or relative to any activity connected with the school including, but not limited to, any caused by the negligence or gross negligence of the school or its instructors, members, agents, employees, operators or authorized representatives. **STUDIO CLOSING DATES:** To be mailed home and/or posted on our website, Facebook and/or Instagram.

**SNOW AND EXTREME EMERGENCY DAYS:** In the event that the studio must close due to snow or extreme emergency, you can call for a message on our answering machine (if weather permits) OR visit our website OR check our Facebook or Instagram. We may email as well. At that time we will give you further information on that matter. There are NO refunds for these closings. The studio schedule accounts for 3 emergency closings, per day of the week.

**RECITAL COSTUMES:** If you choose to be in our recital, we will need a **\$50 deposit by the first week of OCTOBER (\$75 FOR COMPETITION CLASSES)** and **the balance by the first week of JANUARY**. There will a \$10.00 late charge after the first week of JANUARY if the balance has not been paid in full. Once your costume has been ordered, it must be paid in full even if you have decided not to participate in the recital. Costumes will not be given out until costumes are paid in full. You will receive complete details about the recital as soon as the information becomes available.
